M/s CMA CGM SA, France(PAN- AABCC9048G) has applied for a 100% DIT Relief Certificate through its agent in India, M/s CMA CGM Agencies (India) Private Limited(PAN-AADCC3951G) on 28.03.2020 and subsequent letters for its 30 vessels and for the pool arrangement with 19 shipping companies for the F.Y. 2020-21. On perusal of the same, it is certified that shipping income is earned by your principal from operation of following vessels listed below.

The applications as well as the documents, filed in this regard were perused. On prima facie examination of the documents and details, it appears that principal is entitled for the benefit of Article 9 of the DTAA between India and France. In view of this, the principal is entitled for 100% DIT Relief on account of income from operation of the following 30 vessels operating in the international traffic, i.e. freight and other ancillary charges in connection with such transportation, which are either owned or chartered by principal for transportation of passengers, mail, livestock or goods carried on by the principal within Indian ports. However, any income earned for the transportation of passengers, mail, livestock or goods from one place to another place within India is not covered by this DIT Relief Certificate.
